ENTRY REQUIREMENTS - PRIMARY PLAYER: The first player from a household who is an oil industry employee without regard to gender (Fee = \$185). The PRIMARY PLAYER is entitled to invite a playing Spouse or Guest to play in MIXED DOUBLES for an additional fee of \$60. A fee of \$35 will be charged for a non-playing spouse or guest. The PRIMARY PLAYER will be listed in the program with Company Name, and receive the full player ditty bag.

TOURNAMENT PLAY:

WOMEN'S DOUBLES: Play will begin at 8:00AM Friday March 23,2012. This event will include two or more divisions depending on turnout. Three matches are guaranteed.

PRIMARY PLAYER'S DOUBLES: Play will begin at 8:00AM Friday March 23, 2012. This event will include four divisions: "Championship", "A", "B" and "C". Three matches are guaranteed.

MIXED DOUBLES: Play will begin Friday afternoon March 23, 2012. This event will include the same four divisions as the Men's Doubles. Teams will be ranked according to the male player's ranking. Two matches are guaranteed.

SPONSOR ENTRY FEES:

PLATINUM SPONSOR	\$10000 In Cash or "In Kind" Entitles sponsor to enter SIXTEEN PRIMARY PLAYERS with Spouse or Mixed Guests. Platinum sponsors will be so recognized at all tournament functions and in the tournament program.
GOLD SPONSOR	\$5000 In Cash or "In Kind" Entitles sponsor to enter TEN PRIMARY PLAYERS with Spouse or Mixed Guests. Gold sponsors will be so recognized at all tournament functions and in the tournament program.
SILVER SPONSOR	\$3000 In Cash or "In Kind" Entitles sponsor to enter SIX PRIMARY PLAYERS with Spouse or Mixed Guests. Silver sponsors will be so recognized at all tournament functions and in the tournament program.
